 - o FC has sent GeoCom budgets, Comms budgets received from GF
- Anticipating a draft budget by month-end
- Financial year starts 1 January
- We need to plan budget for 2023

- 2. Best Practice Geospatial what does good look like?
- 3. Professional work and engagement
 - Ethics
 - · Diversity and inclusion
 - Skills and education
 - Sustainability

AGI mission pillars remain in place.

Can we produce a graphic for the top 3 opportunities?

AM - Scotland seeing convergence between the geospatial strategy and space strategy. How can AGI strengthen with the space agenda?



- AR Organisations are reviewing activities against the SDG's
- AB Welsh focus is on EO and RS

AB – do we agree on the top 3 priorities – can we publish them now?

RH

- Net zero and EO data which contributes to use cases around energy efficiency, sustainability
- Role of geospatial in increasing impact or outcomes in those areas, but it is a busy area
- KTN report already has power of location, Cambridge Conference has a report, GeoCom recording,
 GC's work on EO. Is there value in collating / curating all the evidence?
- GC are looking to do something in the net zero space. Do we have members, partner members, that have done any work in this space, e.g. OS, ESRI UK

KS - OSNI are keen on EO and AI work and leading steering groups, use EO for benefit of net zero and sustainability agenda. GC is not well promoted or understood in NI.

AB - current focus on sustainability and net zero and the use of EO

Sustainability and wider ESG agenda:

- G7 in Egypt in September
- Spatial Finance is another
- Ethics is the intersection of policy and practice

ECN webinar with UK Space and Satellite Applications Catapult

Webinar on EO and RS with ECN in September

RD - We need collaboration and partnership with space, rather than a specific workshop

Activities


- Public facing listing on AGI website provider of skills

Location Data Specialist qualification - request from RGS

- There is a need for an integrated master's apprenticeship. Allow those in industry to transition.
- Target Knowledge, Skills and Behaviours have been developed.
- Who are the correct organisations to deliver this qualification?
- Do we agree that this apprenticeship is an integrated masters to be delivered by the HSE sector and that there is a need for such an apprenticeship?

RH – is it AGI's place to be supporting one part of the industry over another?

AR – not familiar with such an apprenticeship



RH – the apprenticeship is a good programme and a good thing for employers. AGI should be agnostic about the delivery mechanism.

RH – the geographic community is very broad, CICES, IEMA, CIEM, business management, DAMA, RGS etc... our role as the broad church is to signpost. We are a non-aligned body can look across the pathways to help members find the right career track.

RD – we should do this signposting regardless of whether we bring back our CPD in full. CPD helps you collect points against whatever the appropriate framework you choose to submit against.

RD – is there demand? If we do drop CPD what is the value of our paid membership?
