#### 3 AGI 2030 Vision Development

AGI Identity was discussed at Jacob's earlier in the year and Peter provided an update on the meeting he and Fergus had with RGS Nigel Clifford, Joe Smith and Catharine Souch. A discussion took place on the need to work towards an AGI vision for 2030 and what the UK geospatial industry ecosystem in 2030 will look like. A key question is what will the role of membership organisations be at that time.

Outcomes:

- a) Proposal to organise a round table with other membership organisations in the geo space to look at:
- Relevance
- New membership
- Ecosystem
- Next steps
- b) Discussion on AGIs Unique Selling Points
  - Networking especially outside of one's own organisation
  - Career development
  - No one currently owns the space that AGI exists in i.e. it spans public and private sector, Education and Research, therefore AGI has an important role to play as can be seen by the successful GeoCom events
  - Non-commercial and therefore has neutrality
  - Multi Sector
  - Supports CPD
  - Open culture
- c) What should AGI be doing?
- Social events
- In-person events
- Regional network events
- Set up AGI forums
- Engage more with Strategic Partners
- More UK-wide engagement i.e. hold GeoCom in Scotland, Wales and Northern Ireland every other year and continue with English conference in years GeoCom held in other countries
- Discuss with GC whether there is funding available from them and whether GC would benefit from being members of AGI or have representatives on AGI Council
- Joining up and collaborating with other member organisations such as RGS where feasible, bearing in mind that we work in different spaces. RICS open to conversations re Chartered Geographer. Is there more that can be done in the digital skills space to remain relevant?

# 7 Ian: Skills/Education Update

There was a discussion on registering for networks and events. The proposal is for members and nonmembers to sign up to networks and then have the option to register for events which would have limited places in order that networks are not exclusive but AGI can effectively manage event numbers.



Any new budgets required please let Alan know before October. Ian mentioned the NHS Core Competency framework aimed at professionals working in health as a good skills model.

# 8 Andrew: Membership Update

Andrew was unavailable for the meeting. AGI Cymru advised that they have a representative to join the Membership Working Group.

# 9 Fergus: Standards update

No specific update this time.

# 10 Sara: CPD

Sara was unavailable for the meeting. AGI met with Liz at RGS. Decisions required on whether AGI provide accreditation for CPD or badge events and whether AGI still has the capability to review CPD and professional progression. The GeoPlace conference highlighted a discrepancy in the number of points/hours of CPD that was applied by AGI and RGS. The decision was to push people to RGS to record CPD and that AGI should advertise badging. AGI are still awaiting the CPD survey results.

## 11 Liz/Vida: GeoCom update

The conference title is confirmed as Connecting Communities from a geospatial perspective. There has been a small uplift on ticket prices from last year and a slightly larger uplift on sponsorship prices. 3 sponsors are now confirmed. Richard proposed a round table discussion on the theme of housing and social housing.

Tickets will go on sale in September. There was a discussion on potential speakers and the different topics that connecting communities could cover.

# 12 Vida: ECN update

Vida suggested that emails sent to ECN could be improved upon as they don't always engage this community. Also suggested were those members of this network be offered free tickets for GeoCom.

### 13 Liz: EO Network update

The EO network are meeting at Geovation in London on the evening of 2<sup>nd</sup> October. Potential food and drink sponsors are being looked into, although AGI can cover this if required.
